



The Constitution of the District of GenesiZ

Generation Z ordains and establishes this constitution for the district of *GenesiZ*.

Article 1: Social Wellness

- 1.1 Citizens commit to operate at the highest levels of civility.
- 1.2 Citizens have access to low cost, social-emotional support.
- 1.3 Citizens have access to affordable and quality homes, that include transitional housing.
- 1.4 Citizens are consciously informed about resources available to address mental, physical, emotional health.
- 1.5 Citizens have access to a diversity of recreational activities.
- 1.6 Citizens live in a safe and secure community environment.

Article 2: Educational Equity

- 2.1 All students can expect to learn in a safe and secure school environment.
- 2.2 All students have access to personalized career development.
- 2.3 Prioritization of student, teacher and administrative mental health will be afforded to all members of the school community.
- 2.4 Communities are given license to provide culturally sensitive assessments in addition to standardized assessments.

Article 3: Social Justice

- 3.1 Diversity of race, gender, sexuality, neurological differences, and/or economic status is upheld in practice without discrimination.
- 3.2 The foundation of our justice system begins with the presumption of innocence.
- 3.3 The administration of justice will be impartial to economic status or political influence.

Article 4: Socio-Economics

- 4.1 All Citizens have access to a livable minimum wage.
- 4.2 All citizens have access to housing assistance where necessary.
- 4.3 Entrepreneurial enterprises are aggressively encouraged as an economic vehicle.
- 4.4 District of GeneZis citizens and leaders have access to the highest values of economic equity, without discrimination.

Our aspirations to seek to create a more perfect society require confidence and drive to put this guidance into effect. Those who agree shall move forward with us to create this enclave, a society shaped by intentional focus on positively impacting socio-economics, social wellness, educational equity and social justice.

4 ALARM DECLARATION OF EMERGENCY FOR OUR CHILDREN

We must give our children back the assurance of their future viability through collective efforts and organized solutions. Power is most effective when concentrated. WHEREAS concerned and vested citizens of the state of Georgia duly request the leadership of our state to engage in our triage efforts to identify the needs and design solutions to the problems we face with all deliberate speed. We endeavor to build bridges and make connections to change the negative narratives and sustain our communities.

WHEREAS we acknowledge that what is not changing and improving, is in fact dying. We the citizens of the state of Georgia refuse to sit by and watch our children die. Not on our watch.

WHEREAS with all emergencies, there must be management. Hence, we propose the establishment of a statewide youth commission with a level of accountability commensurate with the urgency of this moment.

WHEREAS the statewide youth commission will identify and aggregate oversight of the funding and pooling of resources for the greater good

WHEREAS this is a collective grassroots effort of organizations, municipalities, community, businesses and educational institutions to focus on programs, practices, policies and people.
